## Eligibility Criteria

1. The scholarship(s) is open to high school seniors that are children, stepchildren or foster children of community bank employees located in Ohio.
2. Applicant must have a minimum GPA of 2.0 through their Junior year of high school to be eligible for the Ray Campbell Scholarship.
3. Applicant must verify acceptance to an Ohio postsecondary institution with studies to begin in the summer or fall following high school graduation.
4. Applicant is required to write a two-page essay (typewritten only) about the impact that community banking has had in their town and/or the state of Ohio – include both community and financial support your bank provides to others. **Please do not reference your town or any other personal information in the essay.**
5. Applications for the scholarship(s) must be received by April 15<sup>th</sup>, 2017.
6. Scholarship(s) awarded will be paid directly to the postsecondary institution designated by the applicant.
7. Applications received will be reviewed by a Selection Committee consisting of no more than five (5) members.
8. Members of the Selection Committee are appointed by a Chairperson each year.
9. Contributions to the Ray Campbell Scholarship Fund are **NOT** tax deductible.
